The City reserves the right to accept or reject any/or all bids and waive any technicalities.

# UNION CITY CEMETERY MAINTENANCE GUIDELINES and REQUIREMENTS

## BID INCLUDES BOTH UNION CITY CEMETERIES: N. WASHINGTON AVENUE AND RIVERVIEW DRIVE/OLD COUNTY FARM ROAD LOCATIONS

- ◆ The contractor must provide the city with certificate of insurance in the amount of \$1,000,000 and \$2,000,000 aggregate; **the face of the insurance certificate shall exhibit ‘The City of Union, Missouri’ as additional insured. Also, an additionally insured endorsement is required. NO EXCEPTIONS, OMISSIONS OR REDUCTIONS TO THIS REQUIREMENT WILL BE ACCEPTED.**

- ◆ The contractor shall sign a 'Hold Harmless' agreement with the City.
- ◆ The contractor shall have and maintain proper equipment to complete the agreement.
- ◆ All vegetation shall be neatly and evenly trimmed with a maximum growth at any time of five (5) inches which includes the area around all markers and fence areas. Any weed/grass clippings falling onto stone markers during mowing/trimming must be swept and/or blown off.

Mowings shall be as follows:

From April 1 through June 30 mowing will be completed three (3) times per month, once every ten (10) days. From July 1 through October 31 mowing will be completed twice monthly. This results in a total of seventeen (17) mowings per season from April 1 through October 31. Each mowing and trimming shall be accomplished within the same two consecutive calendar days. If weather conditions prevent following the above schedule an alternate schedule maybe agreed upon in writing with the city administrator’s approval. In the event the alternate schedule results in less than 17 mowings for a season, a credit will be given to the city in the amount calculated at 1/17 of the total bid price awarded by the Board of Aldermen.

In the event that the City Administrator shall deem additional mowings necessary, the cost will be paid on a “per mow” basis. The City Administrator must approve the additional mowing before it is completed. Payment for such additional mowing will be made on the last day of the month in which the mowing occurs. The payment amount for any such additional mowing will be calculated at 1/17 of the total bid price per the bid awarded by the Board of Aldermen.

- ◆ Payment will be mailed to the contractor on the last day of each month from April through October, at the rate of 1/7 of the total bid.
- ◆ The cemetery shall be kept free of any and all debris with allowances made for grave decoration during one (1) week prior and two (2) weeks after Memorial Week.
- ◆ The City expects that the contractor shall use all reasonable efforts not to disturb memorial items placed at graves, however, City Cemetery rules allow for removal of any items that interfere with maintenance of the cemetery.
- ◆ The contractor shall notify the City Clerk upon completion of each mowing.
- ◆ The cemetery will be inspected by a designated City Official who will note any discrepancies. These discrepancies shall be corrected within 72 hours and if discrepancies are not corrected, the City shall have the right to terminate the agreement and prorate any payment due to contractor.
- ◆ The contractor shall keep the city informed of any problem area and make recommendation or correction of said problem.
- ◆ The City will designate an area for all decorations and debris to be placed.

- ◆ The City of Union and contractor may agree to renew the agreement for subsequent terms at the same rate.
- ◆ Use of herbicides must be approved by the City prior to application.
